5-5-10 YEAR WARRANTY

- A. LED MODULE: FIVE (5) YEARS
- B. POWER SUPPLY: FIVE (5) YEARS
- C. FIXTURE HOUSING: TEN (10) YEARS

LABOR: Within the period of the warranty, if this Product is determined to be defective, Razorlux will repair or replace the Product, at its option, at no charge, or pay the labor charges to any Razorlux authorized service facility.

PARTS: In addition, Razorlux will supply, at no charge, new or rebuilt replacements in exchange for defective Parts within the period of their warranty.

This warranty is based on no more than 12 hours working time a day.

To obtain warranty service, buyer can contact with buyer's local authorized service facility, or deliver the Product freight prepaid in its original package or packaging affording an equal degree of protection.

This warranty does not cover cosmetic damage or damage due to acts of God, accident, misuse, abuse, negligence, or modification of, or to any part of the Product. This warranty does not cover damage due to improper operation or maintenance, connection to improper power, improperly grounded or attempted repair by anyone other than a facility authorized by Razorlux to service the Product.
